WOW! What a meeting we had in Sarasota in early December. It covered

everything from hurricane preparation and recovery, to a walk inside the Ringling Bridge across Sarasota Bay.

The 2 1/2 day meeting started with perspectives of the 2004 hurricane Season presented by Charlotte, Hillsborough, Orange, Indian River and Okaloosa Counties, Florida Department of Transportation and the Florida Department of Emergency Management. It was amazing how each of these entities approached the storms.

RS&H presented an interesting case study on the effects of the recent hurricanes on beaches

and beach renourishment. Everyone from the coastal counties got

practical ideas on how to protect their coastline against future storms. It was interesting to see the actual results of some forecasting

principals. This kind of information will be invaluable for the future protection of coastlines.

The day ended with a lively round-table discussion covering all as-

pects of hurricane planning, preparation, initial response, long-term recovery, dealing with state and federal agencies. flooding, and mutual aid. Each county had

their own views on each topic. They know what worked well and, more importantly, what did not. The outcome was the sharing of ideas to improve Emergency Management Plans for the next hurricane season. Once again. **FACERS** served as the vital connection between counties enabling them to share data and experiences. Personally from Charlotte County's perspective, we will be implementing some of the successful procedures that worked for other counties.

FACERS 2004 LEGISLATIVE CONFERENCE (Continued)

I know all those who attended took home new information to add to their Emergency Management Plan.

The second day began with Hillsborough County laying out their plans to create an assessment project to dredge a residential canal connecting to Tampa Bay. Once again, FACERS members provided experiences and, in some cases, horror stories of failed projects. This information helped shape the Hillsborough County project, saving them from some of the pitfalls experienced by other counties.

Hillsborough County then presented one of their crowning accomplishments. They coordinated the efforts of private developers, FDOT and the County to get US 301 widened in the southern portion of the county. We all have roadway improvements that we cannot afford and end up "piece-mealing" over time. Hillsborough County pulled all the pieces of the funding puzzle together and can now build a four-lane road as a single project. Not only will the road be built sooner, but reduced the total length of construction saving both aggravation and most likely lives. There are several counties that will be calling on Hillsborough County for guidance real soon!

We then discussed the best way to use the proceeds from the NACE 2004 Conference in Orlando. Since we have experienced difficulties in dealing with state universities to award small scholarships, a committee was formed to develop a new plan to support the engineering education in the State of Florida and report back to the general membership during our June 21, 22, & 23 meeting in Tampa (stay tuned for more information on that meeting).

Following the education discussion, we had a brief presentation by RS&HCS on how the new Ringling Bridge was built. This bridge connects downtown Sarasota with Lito Beach, Longboat Key and a very upscale shopping area.

After the presentation, RS&HCS arranged for FACERS to see how the bridge was built. This involved a short trip to the bridge, a climb up a ladder and a walk through the middle of the bridge.

The second day ended with our official "Social Gathering" put together by our Social Secretary, Carolyn Steves, RS&H. We met at the Bayou Blue restaurant in downtown Sarasota. As usual the FACERS crowd knew how to have a good time!
