Transportation Related Legislation Filed for 2020 Session

FACERS continues to recommend legislation to index the local gas tax to the Consumer Price Index to reduce the loss of buying power caused by inflation. This method was adopted by the Florida Legislature for State gas taxes and the State share of gas tax collections is automatically adjusted annually.

Project Spotlight The Sebring Parkway Phase III

The Sebring Parkway Phase III, now knows as The Panther Parkway project is a 4.3 mile 4-lane roadway project which runs between Sebring and Avon Park in Highlands County.

The project started with ROW acquisition around 2000 and was funded many years later as a joint Highlands County/FDOT CIGP project to construct 2 lanes. The project was let out as a design-build project in 2013 with construction slated for 2015. In 2017, with the project stalled due to cost overruns due to the design, the project seemed doomed to be shelved.

In a last-ditch effort, county staff worked together with a second consultant and was able to come up with a design that could be constructed near budget. Concerns were still expressed with respect to constructing 4 miles of a 2-lane roadway with limited passing opportunities. The Highlands Engineering Department suggested a few more changes that would cost slightly more but were much more economical in consideration of scale of construction. In February 2018, the Highlands County Board of County Commissioners were faced with 2 options, shelf the project and repay \$1.7 M in expenditures to FDOT, or proceed with an \$12 M project to construct 4 lanes and 2 roundabouts. Create a great offer by adding words like "free" "personalized" "complimentary" or "customized." A sense of urgency often helps readers take an action, so think about inserting phrases like "for a limited time only" or "only 7 remaining!" Equipment and operators were pieced together from several departments including the Road and Bridge Department, Solid Waste Department, Traffic Operations Department, Parks and Rec Dept, and Engineering Department to work as much as 6 days per week. Twenty-one months later, on December 7, 2019, the project was fully opened to the public with all four lanes and 2 new reconstructed roundabout intersections. The project is not finalized yet, but at the time of this writing, the project is tracking to be on or slightly below budget.
