#### FACERS Presentation at FAC New Commissioner Workshop

On January 10, 2013, FACERS participated in the **New Commissioner Workshop** conducted by the **Florida Association of Counties (FAC)** in Gainesville, FL. This workshop is held biannually following each general election to help acquaint new commissioners with issues they will likely face during their term of office. The presentation was made by John Goodknight, FACERS Executive Liaison, with PowerPoint materials prepared by Ramon Gavarrete and George Webb.

The discussion provided an opportunity to share information with new commissioners about how FACERS, as an affiliate of Florida Association of Counties, supports the Association and provides value to individual member counties. Key points of the presentation were:

- ⇒ FACERS' role in supporting FAC's legislative program by providing technical reviews of proposed legislation;
- ⇒ Significant accomplishments like negotiations with FDOT to change policy to reimburse local governments for the costs of signal and lighting maintenance;
- ⇒ Ongoing activities of the LAP Community of Practice, a collaborative effort by FACERS and FDOT to streamline the process for using federal transportation funds on local roads;
- ⇒ The importance of the Florida Green Book and MUTCD as guidance for decisions commissioners will face regarding traffic regulation and road design.

Commissioners and FAC staff expressed appreciation for the presentation and encouraged FACERS' continued participation in FAC programs.



# FACERS Project Spotlight—Princess Place Bridge Replacement

**BEFORE: OCT 2011** 

Princess Place Preserve is a 1,500 acre county-owned and operated park located in northern Flagler County. This beautiful pre-

serve is rich in history and attracts nature enthusiasts from near and far. The park entrance is located on Old Kings Road, where visitors enter the property along a long, narrow, unpaved roadway. The road extends to the original lodge and Florida's very first inground swimming pool, built along the bank of Pellicer Creek by Henry Cutting in the late 1800s.

Along the route, the access drive crosses Styles Creek

which, until recently, meant that vehicles must cross the tidal, brackish creek via an aging concrete slab one-lane bridge. Bridge inspection reports revealed a number of structural deficiencies making the replacement of this bridge structure a critical priority for the County.

Flagler County requested and received approximately \$650,000 of funding from the Florida Department of Transportation as part of the American Recovery and Reinvestment Act of 2009 to replace the structure. The project was advertised as a Design/Build project. An important aspect of the project was that the design of the bridge be context sensitive. The County wanted a design which would be consistent with its physical setting and would preserve the scenic, aesthetic, histor-

ic and environmental features of the location, while meeting all of the technical specifications required under the federally fund-

ed program.

A clear span timber covered bridge structure, supported by concrete abutments was the design of choice. The completed bridge has one single fourteen foot wide vehicular travel lane and eight foot wide pedestrian walkways on each side of the bridge. The bridge design incorporates a timber covered roof structure with six-

teen foot vertical clearance above the vehicular travel lane portion of the bridge. The roof structure is an open truss design with tongue-n-groove wood roof decking with timber shingles. Lighting accents along the exterior support columns enhance the aesthetic appeal of the structure.
