Recently, she was lead attorney for Orange County's transportation proportionate fair-share ordinance adopted in May of 2006, and lead attorney for the county's school capacity ordinance adopted in March of 2006, implementing a charter amendment relating to school overcrowding. She also represented Orange County in *Mann v. Board of County Commissioners of Orange County*, and in *Morgran Co. v. Orange County*, in which the courts upheld the county's denial of rezoning based on insufficient public school capacity. Ms. Monaco is an adjunct professor at Barry University School of Law and Stetson University College of Law, teaching Land Use Law and Florida Constitutional Law. She currently serves on the Executive Councils of the Environmental and Land Use and the City, County and Local Government Sections of the Florida Bar. Ms. Monaco graduated from the University of Texas at Austin and graduated *cum laude* from Stetson University College of Law, where she was Executive Editor of the *Stetson Law Review*. She also received a Master of Business Administration degree from Stetson University in DeLand.

Susan McCune, AICP, is Project Manager, Transportation Planning Division, with Orange County Public Works Department. Her areas of expertise include growth management, land development regulation, and public participation.
