PROJECT SPOTLIGHT

Palm Beach County's 6th Avenue Bridge Replacement Project

In the heart of the Lake Worth Beach area within Palm Beach County, where east-to-west traffic surges with daily intensity between residential homes, state college and a popular public park, anticipation brewed as plans for the replacement of the 6th Avenue Bridge took flight in February 2022. The scope of work for this over \$11 million vital infrastructure project consisted of the demolition and reconstruction of the entire bridge that spans Lake Osborne, which is a 378-acre lake that is part of a system of once natural freshwater lakes lying along the western slope of the coastal ridge in Palm Beach County just west of the Florida Intracoastal Waterway. It also included the installation of a new stormwater management system, the construction of new sidewalks, curbs and guardrails, the installation of new mechanically stabilized earth retaining walls and the inclusion of a buffered bike lane along 6th Avenue South roadway. On top of this project improving bridge infrastructure within our county, it will also enhance pedestrian accessibility within this residential area.

As construction geared up for the project, conflicts started emerging as the contractor begun demolition of the bridge and found a clearance conflict with the existing overhead utility lines along the north side of 6th Avenue South roadway. Lake Worth Electric company was contacted to relocate these overhead utility lines within this conflict zone of the project. County staff learned that it would cost approximately \$1.5 million to relocate the lines and take up to two years to procure the required materials during which time construction could not continue. It was decided to close the bridge to vehicular traffic to allow construction to continue and that power would be de-energized in the conflict zone. Between March 2023 through April 2023, power was allowed to be shut down during the day to allow work to proceed within the conflict zone. After that date, the load on those power lines were too high to allow for daytime de-energized.

In addition to keep the project moving forward, the contractor needed to perform nighttime work that was expected to last up to 10 weekdays. The Engineering and Public Works Department (EPW) notified the residents within the residing area of the project via a direct mailer about the required night work between the hours of 10 p.m. and 10 a.m. during those 10 weekdays in August 2023. EPW outlined that the work involved driving of sheet piles along the south side of the bridge on both ends. Thankfully between EPW's Construction Coordination Division and the contractor's night crew working diligently and efficiently, they were able to finish the 10 days' worth of night work within just three days. During those three days, they installed 160 feet of steel sheet piles to create a secure foundation for the next phase of construction.

Amidst the inconveniences, they pale in comparison to the transformative impact the new bridge promises to deliver. With the estimated project completion date right around the corner, second quarter 2024, there's a shared recognition that short-term disruptions pave the way for long-term gains within our community. With improved infrastructure comes not only enhanced safety and efficiency but also a renewed sense of pride in our county's resilience and ability to adopt to change.

Greetings from Washington, where election season how now gone into full swing. With both sides of the political spectrum opposed to giving their friends across the aisle any sort of "win", gridlock will continue to top the DC menu.

The past two years has shown why the Infrastructure Investment and Jobs Act was so crucial to county road professionals. No other sector of the economy had a landmark bill signed into law during the Biden Administration's first term, where, like most new presidential administrations, have 2 years of a "friendly" Congress to work with. Much like President Obama's Affordable Care Act and President Trump's tax reform package, one significant piece of legislation is signed into law in a first term. Record funding amounts and record funding opportunities for local governments will be the biggest legislative achievement during the past 4 years. The advocacy of NACE and other infrastructure focused groups can take great pride in knowing their hard work resulted in unprecedented opportunities for local infrastructure investment. NACE members know that is no way to run a budget, as financial certainty is vital to planning for new projects and maintenance. As I write this, there is yet another short-term extension in place. Hopefully, by the time we see each other in Orlando this June, we will have more certainty that we do today (but please, don't hold your breath).

In 5 short weeks, the nation's local road professionals shall descend upon Riverside County (Palm Springs), California for our Annual Conference. While last year's conference was on the Gulf closer to home, we hope many of you are making the trip out west for a conference packed with educational opportunities, continuing education credits, peer exchanges and of course comradery to important to our members. Many NACE members tell us later it was simply the time to chat with your colleagues across the country yielded ideas that brought innovation and cost savings back home with them. When you consider the cost of a NACE conference and yearly membership dues, the value proposition is immeasurable. I encourage all of you to take advantage.

I look forward to seeing many of you in Orlando this June. As many of you know, growing up in South Florida and attending UCF (Go Knights!) make the FACERS conference all the more special for me each year.
