PROJECT & AWARD RECIPIENT SPOTLIGHT-

Local State Agency Collaboration Project of the Year

Hardee County – Road and Bridge Department College Hill Bridge Replacement Project

The bridge construction started in 2019 and was completed in 2022 by Hardee County forces. There were only 20-30 Road & Bridge crews working at that time. Being a fiscally constrained rural county, their manpower and equipment were limited so they relied on their county forces' experience and innovation to complete the bridge work in a timely manner while meeting FDOT specifications and standards.

This Earmark project was only funded with \$325,000 so the County had to fund the remaining balance of more than \$1.5M to complete the bridge reconstruction within a span of 3 years. The total project cost is \$1,866,431.67.





Large Agency Project of the Year

Sarasota County Capital Projects Dona Bay Restoration Phase 2 Surface Water Storage Facility

The Dona Bay Phase 2 project is a continuation from the Dona Bay Phase 1 conveyance improvements and wetland rehydration area which directs the flow to a 364-acre Surface Water Storage Facility. The project has successfully diverted the historic flow to the Myakka River, reduced freshwater flows to the Bay, balanced the estuary system, provided nitrogen reduction, and accomplished the goals of the project.

The design of Phase 2, and the construction phase was completed in substantial conformance with the plans, specifications and conditions permitted by SWFWMD in November 2023.

Total cost for design, permitting, engineering, inspection, and construction was \$15M complete. The project was completed within the contract time frames, on-schedule and under budget.



Small Agency Project of the Year

Englewood Community Redevelopment and Sarasota County Capital Projects West Dearborn Street Improvements

West Dearborn Street Improvements Project which was an ambitious vision of the CRA to revitalize the main street business corridor in Englewood, Florida. This project was completed in May 2023 and included improvements such as angled parking, widened sidewalks with decorative pavers, comfort stations with outdoor furniture, low-maintenance landscaping, decorative streetlights, and a stained-glass pervious pavers incorporated into the street intersections.

The Englewood CRA recognized the need to invest in infrastructure improvements that would enhance multimodal transportation, create a sense of place, and address parking needs in the commercial district of Englewood.

Project Management, Engineering Design/Construction CEI, Construction Cost came in at \$9.1 million.





Urban Engineer of the Year

Polk County Angela Spieler, PE (Project Manager)/Lake Wilson Drive

The Lake Wilson Road project consists of the widening of a 1.26-mile segment of Lake Wilson Road from a 2-lane undivided urban collector to a 4-lane divided roadway from CR 54 (Ronald Reagan Pkwy) to CR 532 (Osceola Polk Line Road) with improvements to both the CR 54 and CR 532 intersections. The project includes lighting, a closed drainage system, a joint use pond, the construction of a wet detention pond and a floodplain compensation pond.

The \$2.6 M design included coordinating with over 20 utility companies, Osceola County, FWC (gopher tortoise relocation), SWFWMD and FDEP (skink survey and wetland mitigation). Due to a utility easement, the County spent \$6.2 M to relocate Duke Energy's distribution and transmission lines. Construction costs were \$20.2 M with an additional \$1.8M in CEI costs.

On Tuesday, September 3, the Legislature released some of the key dates for the 2025 legislative session.

November 19: The Legislature will convene for "Organizational Session" to conduct initial business and select legislative officers.

December 2-6: Committee week 1A (House only)
December 9-13: Committee week 1B (Senate only)

January 13-17, 2025: Committee week 2 January 21-24, 2025: Committee week 3 February 3-7, 2025: Committee week 4 February 10-14, 2025: Committee week 5 February 17-21, 2025: Committee week 6

March 4, 2025: Start of Regular session/bill filing deadline

FAC held its Innovation & Policy Conference on September 18-19 in Escambia County. FAC's policy committees are expected to consider a number of transportation-related policies for its 2024-25 Legislative Action Plan, including Fuel Tax Indexing and Electric Vehicle Registration Fees.

Summer/Fall Member Spotlight: Jay M. Jarvis

Jay Jarvis is the Director of the Polk County Transportation Division. Jay was born and raised in Saint Albans, West Virginia. He attended the West Virginia Institute of Technology, where he obtained his Bachelor of Science degree in Civil Engineering in 1985. After graduating Jay worked for various Consulting firms in Pennsylvania and Florida. In June of 1991, Jay was hired by the Parks & Natural Resources Division of the Polk County Board of County Commissioners in an Engineer position to help develop Polk County's National Pollutant Discharge Elimination System (NPDES) permit submittal to the

Environmental Protection Agency. In 2001, Jay received his Professional Engineering License from the State of Florida Board of Professional Regulation. Later in 2001, Jay was promoted to the position of Drainage Manager; where he oversaw the Operations and CIP for the County's drainage issues outside of the road right-of-way.

During his time as the Drainage Manager, Jay was involved in addressing several drainage/flooding issues throughout the County. From small local roadway drainage projects to large flooding projects. A couple of the larger projects were the Saddlebag Lake project and the Lake Belle project. Both of these lakes experienced significant flooding after the 2004 Hurricanes.

Saddlebag Lake flooding resulted in approximately 300 mobile homes being flooded. The solution was the installation of a gravity drainage system that interconnected 5 lakes to allow flood waters to go downstream over time. The Lake Belle flooding resulted in approximately 15 homes being flooded.
